## **Continued Art Policy Discussion**

Commissioner Goodhart put together a list of items to discuss. The purpose of this list was to clarify the direction of the commission for the staff as they draft the

Todd and Commissioner Marrett also discussed the policy with the Arts Council, who want to discuss it further. The outcome of discussion will be relayed to the Arts Council's next meeting.

1. Because of the limited available installation sites for art and lack of secure storage for a piece that's not fastened to the earth. Will we only accept art via a request for proposal?

- 2. Will the final art acquisition decision always rest with the Port Commission? 2 YES - 1 NO
- 3. Will we seek any outside advice from anyone when we're acquiring art? 3 YES
- 4. If yes (and assuming the Town of Friday Harbor Arts Commission agrees to participate), will we seek advice from that group? 2 YES -1 NO

5. If yes, will we utilize the entire Arts Commission's set of procedures (as written for the Town)?

- 6. If no to question 5, will we ask the Arts Commission to exercise their procedures for recommendations in certain areas, as follows:
  - a. Site selection? 3 NO
  - b. Artist selection? 2 YES -1 NO
  - c. Artwork selection? 2 YES -1 NO
  - d. Art Commission's selection panel makeup? 2 YES-1 NO
  - e. Does a Port Comm. need to sit on panel? 3 YES
  - f. Deaccession of art? 3 NO
  - g. Other management of selected art? (maintenance, rights, insurance, etc.) 3 NO

### Staff's question amplifications:

- 7. If an unsolicited offer of art happens, what should the policy's response be? **Yes**
- 8. Depending on question <u>6. response to site selection</u>, does the Commission want to designate locations available for art? **YES** but open to offers.
- 9. Does the Commission want to provide guidance on the type of art desired?

- 10. Does the Commission want to assign an art budget amount? **NO**
- 11. Does the Commission want to establish a discretionary fund in the budget? The commission would balance support for art, community organizations (EDC, Labs K-12, fireworks, club events/support with economic development connection, pilot's honor wall, etc.), music in the park, art maintenance, advertising, scholarships, and other topics against an established annual budget.

# Director Report:

• Todd reported that the Barge Landing Road project is significantly behind schedule, with the county struggling to manage the work and deciding not to serve as the contract administrator. He may need to write the specifications and hire someone else to complete the project, which could incur additional costs. The project is at least six months behind, and the budget hit so far is around \$30,000 to \$35,000.
